

# COUNTY TREASURERS' ASSOCIATION OF TEXAS LEADERS AND COMMITTEES 2025-2026

## THE TEXAS OUTSTANDING COUNTY TREASURER AWARD (TOCTA) COMMITTEE:

Section 6. The President shall appoint the Chair from the standing Committee which shall be composed of all Past Presidents and two members at large who have served as Region Directors with 8 years tenure as a County Treasurer. The Committee shall confirm at the County Treasurers' Spring Education Seminar the selection of at least two but not more than five nominees for the Outstanding Treasurer from nominations made by each Region. Region Directors shall obtain nominees for Outstanding Treasurer from members of their Region. By secret ballot prior to the Spring Education Seminar, each Region shall vote and elect their nominee for Outstanding Treasurer. The nomination and a short biographical description shall be forwarded to the Chair of the TOCTA Committee for consideration by the Committee, provided notice of such nomination has been filed with the Chair not less than thirty days (30) days before the date of the Spring Seminar. If bio is not submitted with the name or if a name is not submitted within the 30 days, the Region will have forfeited their nomination.

Nominees of the TOCTA Committee shall be voted on by the Elected or Appointed County Treasurers allowing one vote per County. Voting may occur electronically or in person with voting ending at a designated time at the fall Annual Conference. Ballots shall be collected by the Auditing Committee Chair who shall be someone other than a candidate for Outstanding Treasurer. After ballots are counted, a report will be given to the TOCTA Chair, who will announce the award at the banquet at the fall Annual Conference.
